Ambassador Program Agreement

This **Ambassador Program Agreement** (Agreement) is entered into between Elliot Australia Pty Ltd ABN ????????????? (Company), and the Ambassador identified below. By signing below, Ambassador agrees to be bound by the Agreement.

1. Company has the right in its sole discretion to accept or not to accept Ambassador's request to join the Ambassador Program (Program) and/or Company may terminate Ambassador's enrolment in the Program at any time.

In doing so, Ambassador will only rely on information concerning Elliot as found in the Company website (elliotaed.com.au), the Elliot Brochure ([link](#)), the Elliot Technical Manual ([link](#)) and any official marketing collateral provided to Ambassador by Company.
4. Ambassador may not provide its Coupon to other people/entities so that they can act as 'sub-Ambassadors' by offering the Coupon to their contacts.
5. Ambassador will be provided with a Coupon personalised only for Ambassador.
6. The Coupon should not be published and only offered to Ambassador's End Customers selectively. If Company in its sole discretion believes that Ambassador is abusing the Coupon in any way, including by publishing the Coupon to multiple recipients, Company may deactivate the Coupon without notice to Ambassador or End Customers.
7. Should an End Customer purchase an Elliot from Company website and enter Ambassador's Coupon on checkout, End Customer may receive a \$50 discount for every Eligible Sale (completed, non-returned device sale).

8. By no later than the end of the month following the month the End Customer makes the Eligible Sale, Ambassador will receive a Referral Fee from Company of \$50 paid into Ambassador's account as noted in the Agreement unless End Customer does not complete the purchase and/or returns the Elliot to Company in that period in which case no Referral Fee is due.
9. At any time and in its sole discretion, Company may alter the Discount and/or Referral Fee amounts.
10. Ambassador agrees to protect the reputation of Company, to not use Company's intellectual property including logos and images except as agreed with Company and to always act in good faith with Company.
11. Governing law is New South Wales, Australia and the currency is Australian dollars.
12. Company reserves the right to update the terms of the Agreement at any time in its sole discretion.
